Event Terms and Conditions

Application of Terms and Conditions

In these Terms and Conditions, "**AAHMS**" means the Australian Academy of Health and Medical Sciences Limited ACN 167 124 067.

You accept these The Terms and Conditions in respect of any event organised or held by AAHMS (**Event**) upon the earlier of you:

- 1. submitting a completed registration form;
- 2. purchasing a ticket to the Event; or
- 3. attending the Event.

Registration

If attending the Event requires the purchase of a ticket, you will be required to pay the purchase price of the ticket as directed by the registration form or AAHMS.

Unless otherwise agreed by AAHMS (at its sole discretion), you must provide us with all the information requested by the registration form and such information must be accurate. You must notify us of any changes to that information (including, without limitation, your contact details).

You must notify us of any special access requirements or dietary requirements at the time of registration, and in any event, in advance of attending the Event. If you fail to do so, you acknowledge and agree that AAHMS may not be able to comply with your request(s).

If you are registering on behalf of another person, you acknowledge and agree that:

- 1. you have provided that person with a copy of these Terms and Conditions;
- 2. the other person is attending the Event as your agent; and
- 3. you are wholly liable (without limitation) for any and all acts and omissions of that person in connection with the Event.

No unauthorised sales

You are not permitted to resell or offer for resale your ticket(s) without AAHMS' prior written consent. If a ticket is sold or used in contravention of this condition, the ticket may be seized or cancelled without refund or exchange and the person relying on the ticket may be denied admission to the Event.

Cancellation

You are entitled to a full refund of the purchase price of your ticket if you cancel your registration or attendance at least seven (7) days before the Event. Refunds for cancellations by you after this date are at the sole discretion of the AAHMS.

Subject to schedule 2 to the *Competition and Consumer Act* 2010 (Cth) (**Australian Consumer Law**), if the Event is cancelled, rescheduled, significantly relocated or subject to a major change due to:

- 1. the act or omission of any person or entity other than AAHMS; or
- 2. any event beyond AAHMS' reasonable control, including but not limited to acts of God, floods, storms, fires, any other natural disasters, civil commotions, public health emergency, pandemics, acts of war or terrorism,

then AAHMS will have the sole discretion and absolute right to elect to either:

- (a) reschedule the Event, including by delivering the Event either wholly or partly virtually;
- (b) issue a partial or full refund; or
- (c) not issue any refund.

AAHMS may cancel, reschedule, significantly relocate or change any aspect of the Event in its sole discretion at any time. Where AAHMS cancels, reschedules, significantly relocates or changes any aspect of the Event applicable laws (including the Australian Consumer Law) may entitle you to a refund of your ticket. Where such law (including the Australian Consumer Law) does not apply, you will not be entitled to any refund or exchange of your ticket in such circumstances.

If AAHMS cancels, reschedules, significantly relocates or changes any aspect of the Event, AAHMS will attempt to notify you of the cancellation, reschedule, relocation or change. However, AAHMS does not guarantee that you will be notified prior to the Event.

To the extent permitted by law (including the Australian Consumer Law), AAHMS:

- 1. will not reimburse you for auxiliary expenses (such as travel, accommodation, carparking) or other consequential loss suffered by you in connection with your attendance or non-attendance at the Event; and
- 2. is not liable to you for any amount beyond the face value of your ticket.

Conditions of entry

While attending the Event (whether in person or online), you must not engage in or threaten any conduct that AAHMS reasonably considers to be harassment (including sexual harassment), bullying, vilification, discrimination, offensive, disrespectful or unlawful. Any failure to comply with this condition may result in:

- 1. you being refused entry or required to leave the Event (if online) or the venue where the Event is being held (**Venue**);
- 2. your ticket not being exchanged or refunded unless required by law (including the Australian Consumer Law); and
- 3. you or your organisation which you represent (if applicable) being barred from attending any future Events.

By attending the Event, you agree to the Venue's conditions of entry. You may be refused entry or required to leave the Venue if you do not comply with the Venue's conditions of entry. In such circumstances, tickets will not be exchanged or refunded unless required by law (including the Australian Consumer Law).

The use of photographic or recording devices of any kind is not permitted, unless otherwise expressly permitted by the Venue or AAHMS.

Limitation of liability

To the extent permitted by law (including the Australian Consumer Law), AAHMS is not liable to you for any loss, damage, injury, delays, additional expenses or inconvenience arising as a result of or in connection with:

- 1. your attendance or non-attendance at the Event; or
- 2. a breach of these Terms and Conditions by AAHMS.

Where liability cannot be excluded or modified by law, including under the Australian Consumer Law, the liability of AAHMS will be limited to the minimum extent permitted by law.
